2. Proof of payment must be sent to accounts@jcsportsnamibia.com prior to attending first training session.
3. Parents/legal guardians are aware Pupkewitz Toyota Cricket Academy makes use of video/ photo analysis and technology during coaching sessions. The video/photo analysis technology is only used for coaching purposes and may be kept on a database for later review to monitor performance improvements.
4. Parents/legal guardians are aware Pupkewitz Toyota Cricket Academy may at times post video's/ photo's on social media platforms.
5. Players to bring their own playing equipment and clothing to training sessions.
6. This membership agreement is a legally binding contract between you and Pupkewitz Toyota Cricket Academy. You agree that this contract sets out the complete agreement between you and us.
7. By entering into this agreement, you purchase a membership for services, and you agree to all the terms, conditions, rules and regulations of this agreement and the Pupkewitz Motors Sports Center.

RULES AND REGULATIONS

1. Parents/ legal guardians are welcome to watch training sessions, but are not permitted to intervene with the coaches or coaching sessions unless requested to do so by the coach in charge.
2. Mobile phones are not allowed to be used by players during sessions unless prior consent is received from the coach in charge of the session.
3. The Facility has a liquor licence, however, tobacco and alcohol are prohibited inside the training facility and sports shop during training sessions. Parents wishing to enjoy a refreshment, can do so in the outside seating area or upstairs viewing deck.
4. Parents/ legal guardians may not film or take pictures of training sessions unless prior consent from coaches is obtained.
5. Food and beverages are permitted; however, they are not permitted on the training surface and may only be consumed in the outside seating area or upstairs viewing deck
6. The employees, coaches or owners are not responsible for lost, stolen or damaged personal equipment in the training facility.
7. No individual shall leave any litter, trash, debris or clothing in the Facility. All trash and debris should be placed in the appropriate designated waste receptacles.
8. Sport specific trainers/ shoes are required to be worn inside the training facility. Metal spikes, formal shoes, high heels or any other shoe which may cause damage to the playing surface is not permitted.
9. Failure to comply with any of these rules may result in the player/ parent/ legal guardian being requested to leave the facility.
10. Memberships are not refundable.
11. Management reserve the right to cancel memberships and refuse admission into the facility should the terms, conditions, rules and regulations not be adhered to.
